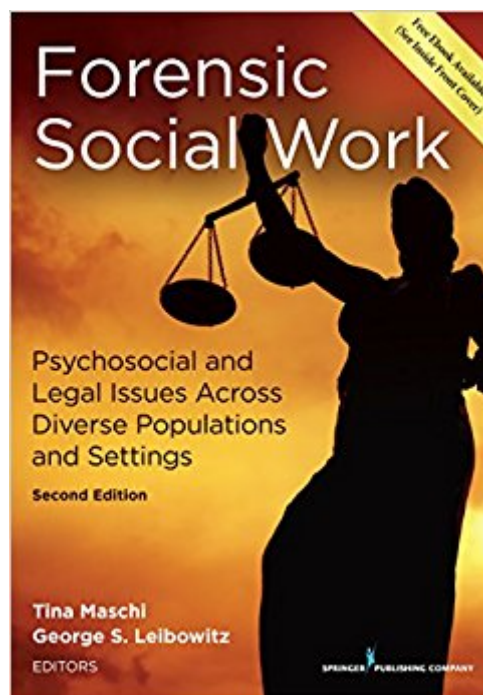

He is a licensed clinical social worker and was listed with the State of Colorado as a sex offense-specific treatment provider and evaluator. Dr. Leibowitz provides training and consultation to several agencies nationally involving risk of sexual harm cases. His research agenda includes developing etiological models of sexual aggression, trauma-informed practices with families and incarcerated populations, restorative justice, and assessment and interventions with juveniles who present with sexually harmful behavior. He has published articles in journals such as Trauma and Dissociation, Criminal Justice and Behavior, and Journal of Child Sexual Abuse.
