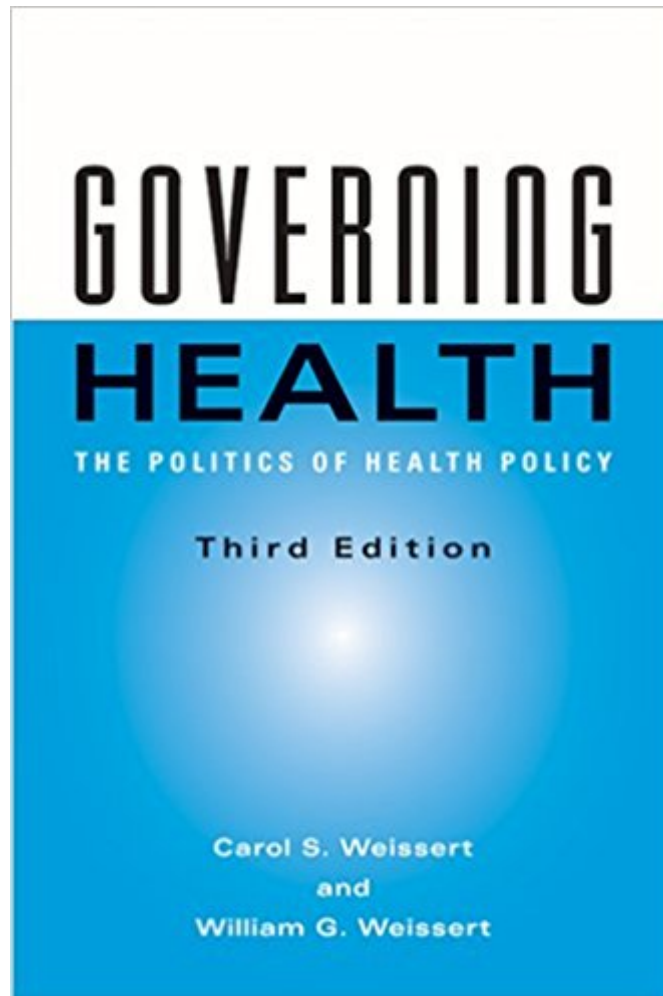

This textbook first and foremost provides you with a comprehensive overview of U.S. politics and how decisions are made. Within this framework, specific examples are given on how decisions about U.S. healthcare are made. Subjects from lobbying to healthcare reform are covered. It also provides information on other parts of healthcare in the United States, such as government run healthcare programs like medicare and medicaid.While reading it, I found myself thinking that the book focused more on politics in general and less on healthcare policy. In this regard the book would be a great primer for anyone very new to politics in general, but someone well versed in politics may need to skip over several sections.
