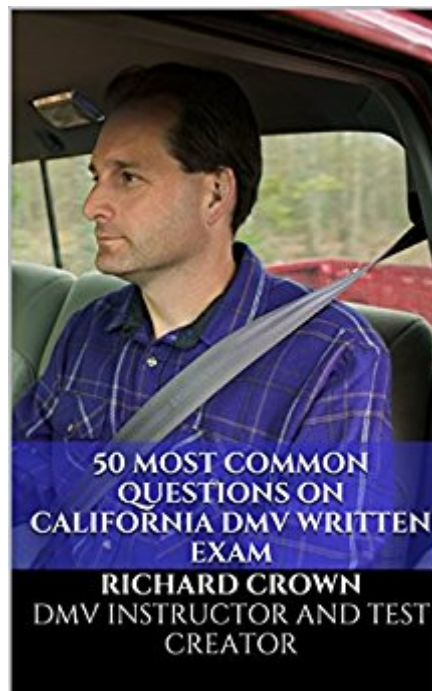

There is a mistake in the list of questions and answers. 47. U-turns in business districts are: incorrectly marked as correct: Legal whenever oncoming vehicles are not a hazard. Correct answer is: Legal only at intersections, unless a sign prohibits them. Also, amount of damage over which you have to report an accident to the DMV went from \$750 to \$1000 in 2017
